Notice of Organizational and Personnel Changes

[Changes effective November 1, 2017]

(1) Organizational change

The Company will establish the following new organizations and reorganize and rename the existing organizations to develop a management structure to accommodate expansion of the scale of business and operational areas of the Park24 Group.

- —Divide the Planning and Administration Division and establish the Corporate Planning Division and the Corporate Administration Division.
- —Transfer the New Business Planning Department, which is under the control of the New Business Division, to the Corporate Planning Division, and the B-Times Department to the Sales Promotion Division of Times24 Co., Ltd.
- —To strengthen human resource development, the recruitment and education functions of the Group-wide Human Resource Department and the function of CS Improve Office of Times Communication Co., Ltd. to establish the Group-wide Human Resource Development Department.
- —To promote streamlining of accounting operations, establish the Operation Control Division and transfer the Group-wide Accounting Department and the Operation Management Department to be placed under the division, and establish the Operation Control Department.
- —To strengthen the ICT (information communication technologies) functions, consolidate the organizations of the Business Development Division (the Times Club Department, the Tanoshii Machi Department and the Mobility Research Institute will become independent from the Business Development Division) into a renamed organization, ICT Development Division.
- —Establish the International Business Division to strengthen the international business, and establish the Europe Business Department, the South east Asia and Oceania Department and the Asia Business Department under the division.
