## **Notice of Change of Business Segments**

Park24 Co., Ltd. announces that the Group will be changing its segments from May 1, 2011 to the following. Accompanying this change, financial reports beginning from the third quarter of the term ending October 2011 shall be made under the new segments.

### 1. Reason for Change

Accompanying the reorganization of the company structure (namely, the transition to a holding company) implemented on May 1, 2011, a study was conducted regarding the change of reportable segments based on performance management divisions, in consideration of the management approach by the management executive. As a result, a partial revision based on current segments is to be made to ensure that the divisions and their naming are even simpler to understand.

#### 2. Contents of the Revision

- (1) Change the naming of current Rent-a-Car Business to Mobility Business.
- (2) Add Road service to Mobility Business.
- (3) SPC Times, currently included in the segment for the Parking Business to be integrated with ST.
